Quilt Competition Rules & Entry Form Entry Deadline: October 1, 2021

Dear Entrant,

Thank you for your interest in our 2022 Quilt Competition. So many changes have occurred to quilt contests due to the mass show cancellations caused by the COVID-19 Pandemic. We have been trying hard to keep Road's contest at the same standard of excellence it was prior to the pandemic. In order to keep with those standards, we have had to make a few changes.

Some of the major prizes have been adjusted to ensure we can keep categories for all types of quilts. Gammill has generously sponsored the Best of Show prize at Road for \$10,000 again. Many of our generous sponsors have signed up to continue supporting the contest. Unlike other events, all sponsor dollars raised go directly to the contestants! We are thankful for their support in our goal to be one of the premier quilt competitions in the United States and the World. Some specialty awards will be a bit different this year and other specialty awards may be put on hold until our industry fully stabilizes in 2023. We are continuously recruiting sponsors to attempt to get our awards dollar value back to pre-pandemic levels.

In keeping with our long term goal of capital investment into our quilt contest, the entire quilt display will be housed in the Ballrooms at the convention center - including the award winning quilts. This gallery approach gives you a unique viewing opportunity for the quilts in a relatively quiet environment so you can enjoy the true beauty housed there.

Due to the addition of the International Sewing Arts Festival, the Road to California show dates have all shifted up one day and the preview night will now occur on Tuesday January 18 with both the Quilt Display and Vendor Hall open for business. Quilt unpacking will occur on January 15 and judging on January 16 - 17. Quilt Pick up will be on January 22 and FedEx will pick up domestically shipped quilts on January 24.

We have included a preliminary awards listing with dollar amounts for you. These awards are subject to change (and will change) before we get to Road in January.

If you entered a quilt in the Road@Home contest in January and your quilt meets rule #1 for the date allowance, you can enter your quilt in the Road to California 2022 contest. We want to make sure quilts that missed an opportunity to be displayed at Road are able to enter the contest for 2022. Quilts may not have been entered in the 2020 Road to California in person quilt contest.

Our international shipping protocols will also be changing. We are investigating giving our entrants the option to use USPS or FedEx for return shipping. We would love international entrant feedback as to which service they prefer and why.

Contest Rules

1. Each entry must have been completed after January 1, 2019 and may not have been *displayed* at any previous Road to California Contest. Quilts that have been altered, amended or modified at any date after the original completion date retain the original completion date. Please Note - this is a temporary additional year due to COVID-19.
2. Contestant is limited to 3 entries, 2 per category. Exception: Group Quilt & Quilter for Hire. If you sign the entry form, it counts as one of your limited entries. If you are listed as a maker, but another member enters the quilt, it does not count.
3. Entry must consist of three (3) distinct layers - top, middle layer, and backing. Quilts must be quilted by hand and/or machine. Crazy Quilts may be tied instead of quilted.
4. No pre-quilted fabrics may be used. No pre-printed wholecloth quilt tops may be used. Quilts made from kits will not be accepted. This includes, but is not limited to: block of the month quilts made from fabrics pre-selected for the quilt maker .
5. No rigid frames, rods or mounting devices, or special lighting may accompany quilt. No rods may be sewn into the sleeve.
6. Quilts that require special handling will not be accepted. Your quilt must be able to be stacked with other quilts and boxed and/or rolled with other quilts without potential damage to your quilt or any other quilt in the show. Road to California, at its sole discretion, has final determination. Quilts that fall under this rule may be disqualified. The entrant will be notified and no fees refunded.
7. Quilts must be a single unit. No rods or other apparatus (including frames) may be sewn into the sleeves of the quilt.
8. Multiple panel quilts and odd shaped quilts with multiple panels must be mounted on black fabric containing a 4 inch sleeve. The top half these quilts must be securely sewn to the black fabric. The black fabric must not extend past the edges of the quilt.
9. All quilts must have a 4 inch double sleeve attached to the top of the back of the quilt for display. No special hanging hardware will be accepted and quilts requiring special hanging instructions will be disqualified.
10. Quilts measuring longer than 86 inches must have a second 4 inch sleeve sewn at the bottom of the quilt across the entire width of the quilt. Quilts without the proper sleeve are subject to disqualification.
11. Quilts must be labeled with maker's name and contact information. **The label must be basted over or covered with blue painters tape to preserve anonymity during the judging process.**
12. All quilts should arrive clean and free of strong odors. Road to California reserves the right to not display an entry if the quality or condition does not meet Road to California's standards upon a hands on inspection. In such a case no fees will be refunded.
13. A group quilt is defined as three or more people working together on the quilt. It must be a true collaboration between quilters and not a business arrangement or part of a work-for-hire agreement.
14. Road to California will insure each accepted entry against a major catastrophe from the time we receive the entry until it arrives back to the owner as follows: Large Quilts - \$500, Wall Quilts - \$300, Miniature - \$300. It is highly recommended that entries over the above stated values be appraised and the entrant possesses appropriate insurance to cover any damage to the entry while in transit and at the 2022 Road to California Show. Every attempt is made to ensure the security of your entry at the 2022 Road to California show. It is the responsibility of the entrant to insure their quilt further.
15. All prize checks including two-person entries and group entries will be issued to the individual who signed the entry form. Only one prize ribbon is awarded.
16. Be sure to select the proper category for your entry. The jury reserves the right to change an entry category. The judges determine final category placement.
17. Each entry must include a digital image featuring the full view of the quilt and a digital image featuring a close up view of the workmanship of the entry. Digital image must be 2,000 pixels on the smallest size and color correct.
18. The written description must be no longer than 450 characters. Road to California may edit the description at its sole discretion.
19. The Road to California entry fee is \$40. Entries submitted fully online receive a \$10 discount.
20. Entry deadline is October 1, 2021. A complete physical entry packet must be received by 3 PM PST, online entry closes at 11:59 PM
21. All decisions of the jurors and judges are final. Road to California may disqualify any entry including those that fail to follow the quilt contest rules.
22. Accepted entries must be available for judging and exhibition from December 23, 2021 to January 24, 2022. Entries hanging in the show may not be taken down early for any reason.
23. All entries must comply with Road to California, Inc.'s statement on copyright releases. It is the responsibility of the entrant to receive written permission if you quilt falls under our Copyright Release Requirements. Road to California, Inc. at its sole discretion may request the written release from the entrant at any time. If Entrant fails to provide written permission, entry will be immediately disqualified and if any prize money is due, prize money will be withheld.
24. Categories 1-5 must be Makers Original Interpretations or Original Designs. Please note: ALL categories must comply with the Road to California, Inc. Statement of copyright, see rule 23.
25. Size Requirements. Categories 1-5 have no minimum size, and must not be larger than 480 inches perimeter. Category 6 maximum perimeter is 96 inches. Categories 7-10 are split into two sizes, Wall with a minimum perimeter of 97 inches and maximum perimeter of 284 inches, and large with a minimum perimeter of 285 inches and maximum perimeter of 480 inches.

Category Definitions

- 1. Abstract** – Quilts entered in this category should reflect principles of abstract design. Forms and compositions should emphasize color, line and design. Quilts should be abstract, cutting edge and non-literal.
- 2. Animal** – Quilts entered in this category should feature an animal or creature as the centerpiece of the quilt. Can include other sub-design elements, but the animal or creature must be the primary focus of the quilt.
- 3. Human Image** – Quilts entered in this category should feature some recognizable aspect of the human form.
- 4. Naturescape** – Quilts entered in this category should illustrate an aspect of a natural scenery. Creatures and animals may be a component, but should not be the focus of the quilt.
- 5. Pictorial** – Quilts entered in this category should illustrate a recognizable image (Cityscape, Wildlife). Use this category if your quilt combines aspects of the other categories listed above.
Quilts Entered in 1-5 must be original design or original interpretation in design.
- 6. Miniature** – Quilts entered in this category should have overall patterns that show reduced size and miniaturization. Miniature wholecloth quilts should be entered into this category. Quilts entered into this category, should be traditional in style.
- 7. Appliqué** – Quilts entered in this category should reflect traditional principles but may deviate from tradition. The quilt should be composed at least 50% of appliqué, in any technique (fused, machine, hand, etc.)
- 8. Pieced** – Quilts entered in this category should reflect traditional principles but may deviate from tradition. The Quilt Should be constructed by piecing, either hand or machine.
- 9. Mixed** – Quilts entered in this category should reflect traditional principles, but may deviate from tradition. Enter your quilt in this category if the predominate construction method is a mix of both piecing and appliqué.
- 10. Other** – Quilts in this category should reflect traditional principles but may deviate from tradition. Enter your quilt in this category if it includes one or more of the following construction techniques: whole cloth, crazy quilts, embroidery and fabric manipulation.

Size Requirements

1. Miniature - Maximum perimeter is 96 inches.
2. Wall - Maximum perimeter is 284 inches.
3. Large - Maximum perimeter is 480 inches.
4. All other Categories- No Minimum Perimeter; Maximum perimeter is 480 inches.

Timeline

October 1, 2021: Complete Entry Packet Received by Road to California (Online or Mail In)

November 29, 2021: Entrant notification including, if accepted, shipping and return instructions. All information will be sent via email from info@roadtocalifornia.com

November 29, 2021 - December 23, 2021: Accepted Entries must be received in our office.

January 18, 2022: Judges comments & award winners notified via email (late evening). If you wish to come help hang the quilts, hanging occurs January 17 & 18.

January 22, 2022: You can pick up your entry after 4:00 PM

January 24, 2022: Domestic Entries return shipped.

February 1, 2022: International Entries return shipped.

Online Entry System Specific Instructions

Please note the following about the online entry form.

The Design Basis line should be filled in. This line should include any inspiration, including pattern, book, etc. This line is printed on the Quilt Sign at the show so it should give any credit that you need to give.

Photos must be a minimum of 2,000 pixels per side. Please note: depending on the size of your photos, the upload may be slow. We recommend your photos to be less than 4 MB in size.

The online form will ask you for a photo of the back of your quilt. This is not required. Only the Front view and close up are required. The jury will disregard any photos of the back of your quilt.

If you get stuck, you can email us at info@roadtocalifornia.com. We will be able to assist you through the entry process.

Road to California, Inc. Statement on Copyright Releases

If you use the designs, photography, art, pattern or quilt created by another person as the source of your quilt's design, you must obtain that individual's written permission before displaying your quilt publicly and entering it for competition. This applies whether you have copied, altered, or used only a portion of the design.

This is considered derivative work, which by definition is "something that is based on another source" and "imitative of the work of another person." Designs are considered intellectual property and are covered under the copyright laws of the United States.

Please note that when you see the word "permission" referenced in this document, it refers to written permission. Written permission is any written document (email included) that must be specific about what permission the copyright holder has granted you. It is important to keep the release for your records, and to be able to produce it when asked. This not only protects you, but releases any liability you may have with any show or venue where you display your work.

I Used Someone's Design as Inspiration for My Quilt.

Most quilters fall under this situation. If someone else's work is identifiable in yours, you should still ask for their permission. If it is not identifiable, it is still common courtesy to credit the artist and the work that provided the inspiration on your entry form.

I Purchased my Pattern, Book or Magazine. They sold the Patterns to be used. Doesn't that Give me All the Permission I Require?

Purchasing the pattern, book or magazine simply gives you permission to make the quilt for your own use. To show it publicly, enter it into competition, or use it for commercial purposes, you must have the pattern designers written permission.

How do I obtain the Permission I Need?

Check the inside cover pages of the book or magazine and the back of the pattern. You may find the contact information or the artist's website information there. If the information is not printed there, contact the publisher and/or search for the artist's website on the Internet.

Begin with a short letter or email. Tell the artist that you have made a quilt from their pattern or artwork and attach a photo. Ask their permission to enter it for competition and to publish photographs with proper credit given. Depending on the situation, you may need the publisher's permission as well.

What if the Designer Denies Permission?

Unfortunately, there is not much you can do. You can ask why. Always remember, you get farther with Honey than with Vinegar. If you still cannot get written permission from the copyright holder, you cannot enter you quilt to competition without putting yourself at risk of legal action from both the copyright holder, and potentially the shows and venues you enter your quilt into.

What Else do I Need to do?

Once you have received written permission, you must give proper credit to the artist or designer everywhere the quilt is displayed. Please use the Design Inspiration to give proper credit to the copyright holder under this entry form. Provide the Artist or designer's name, the title and publisher of the book, magazine or pattern, the website where you found the artwork or any other important information. If you run out of space on the design inspiration, please use part of your quilt description to complete the copyright information.

What if the Artwork is in the Public Domain?

Credit the artist and state that the work is in the public domain.

What if I Cannot Locate the Artist or the Artist is Deceased?

If you cannot locate the artist, or if the artist is deceased, contact the publisher, or in the case of a photograph or other artwork, contact the place or website where you found it. This could include art galleries, colleges, or museums. They may own the copyright or be able to put you in touch with the copyright owner.

Please note: Even if the original artist is passed away, there is a good chance the copyright is still in effect. Copyrights in the United States last at least 70 years after the death of the original artist.
